FREE OF CHARGE (suggested donation : 5\$ or 10\$/person depending on means)

CAB volunteers have been trained to collect your documents and fill out income tax returns.

Eligibility criteria * Pay attention, some have changed

- Single person : annual income of 35 000 \$ or less
- Couple : annual income of 45 000 \$ or less
- 1 adult with 1 child : annual income of 45 000 \$ or less
- 2 500 \$ more income for each additional dependent
- And you earn less than 1 000 \$/year in interest

Required documents

- Tax slips of 2021 (T4, R1, etc.)
- 2020 federal and provincial notices of assessment
- Any relevant document depending on your situation (medical expenses, etc.)
- RL-31 slip for tenants
- municipal tax bill for owners
